#### **GENERAL CONDITIONS:**

1. All the candidates admitted for Ph.D. in November, 2022 and who have completed the course work in their respective subject are eligible to appear for Ph.D. Course Work Examination.

- 2. All the candidates willing to appear for the examination have to submit the filled in Examination application form the following enclosures:
  - i. Photocopy of the qualifying Examination (PG Degree Certificate),
  - ii. Copy of admission letter from the Dean concerned,
  - iii. Joining Report in to the Ph.D. course endorsed by the Principal, and Dean.
  - iv. The receipt of the Exam fee, paid into the Principal's account.
  - v. The candidates who have passed the PG Course from other than Palamuru University have to submit the Migration certificate (original).
  - vi. Xerox copies of the application forms and photograph are not permitted.
- 3. Principals are requested to submit the Examination application forms duly signed by the Candidate, Supervisor, Head and the Principal to the examination branch on or before the last date. The delay in submission will attract penalty of Rs. 1000/- per day.
- 4. The Principal is requested to verify and forward all the application forms immediately along with the following documents:
  - i. Nominal Roll
  - ii. Subject wise-titles of Paper-II (Specialization paper)
  - iii. Consolidated fee Statement.
- 5. Not to collect the Exam fee but to Collect memo's fee only from the Visually Challenged, Physically Challenged, Hearing Impaired & Orally Challenged students. A Xerox Copy of the Medical Certificate confirming their status as Physically Challenged (Minimum percentage of disability must be of 40%) must be attached to the Application forms. These Students' Application forms should be submitted separately along with a Separate Nominal Roll.
- 6. The Principal is requested to Transfer the examination fee amount, collected from the candidates, into "Registrar Palamuru University Exam Fee Fund A/C No. 62078258948 (SBI, Ganesh Nagar Branch, Mahabubnagar IFSC Code SBIN0016375") through RTGS/ NEFT and submit the receipt obtained from the Bank to the Examination Branch. Any excess fee paid will not be refunded.
- 7. All the students are hereby instructed to deposit Examination fee into their respective College Principal's Account only and not to obtain DD in favor of the "Controller of Examinations", Palamuru University.
- 8. Last date for submission of application forms &nominal rolls along with Fee receipts to the Controller of Examinations, P.U is <u>16-11-2024</u>.
