- All the candidates of B.P.Ed. affiliated colleges of Palamuru University are hereby informed that the Examinations of B.P.Ed. II & IV Semester (Regular/ Backlog/ Improvement) and Semester-III (Backlog & Improvement for 2021 batch only) are scheduled in the month of September, 2023. The detailed Time-Table will be notified in due course.
- 2. <u>Candidates belonging to the academic year 2016-17 and prior to this academic year should</u> <u>not apply for any of their backlog paper(s).</u>
- **3.** Further, it is informed that the candidates of **B.P.Ed.** who were admitted during the Academic year 2017-18 & 2018-19 (i.e., 2017 Batch & 2018 Batch), have to PAY Rs.1000/- for each backlog paper in addition to normal examination fee.
- **4.** This is the last chance for the candidates admitted during the academic Year **2017-2018** to appear for the backlog examinations.

 Examination application forms for B.P.Ed II-Semester (Regular) have to be apply Online through college login and others have to applied offline. In addition, hard copies of Examination Application Forms (EAFs) (Online & Offline) duly signed by the student and the principal concerned along with photocopy of qualifying examination / Hall Tickets are to be submitted to the Examination Branch. Xerox copies of Examination Application Forms & Photographs will not be considered.

- 2. Principals are requested not to forward/submit the EAF of Not Eligible Candidates. The results of Not Eligible candidates will be cancelled at any stage, if at all they have written the examination.
- **3.** Not to collect the Exam fee (Collect Memos fee only) from the Visually Challenged, Physically Challenged, Hearing Impaired & Orally Challenged students. A Xerox Copy of Medical Certificate confirming their status as Physically Challenged (Minimum percentage of disability must be of 40%) must be attached to the Application forms. These Students' Application forms should be submitted separately along with Separate Nominal Roll.
- 4. All the students are hereby instructed to deposit Examination fee into their Respective College Principal's account only and are advised not to obtain the DD in favor of the Controller of Examinations, PU.
- 5. The concerned Principals are requested to TRANSFER (Cash deposits / Challans are not accepted) the fee amount through RTGS / NEFT for credit into "Registrar, Palamuru University Exam Fee Fund A/c No 62078258948 (SBI, Ganesh Nagar Branch, Mahabubnagar, IFSC Code "SBIN0016375")". No Demand Drafts are accepted at core Banking section at Exam Branch, PU.
- 6. The Principals are requested to verify and forward all Hard Copies of E.A.F. along with

 - c. Fee Abstract and Fee Receipt
 - d. A copy of PU Affiliation Orders for the Academic Year 2022-2023

7. PAPER-WISE IMPROVEMENT IS PERMITTED IN THE NEXT IMMEDIATE EXAMINATION AFTER COMPLETING THE SEMESTER AT A TIME ONLY.

- 8. The College will be held responsible for any mistake committed while filling the Candidate's name, mother's name, father's name and paper title (Theory & Practical). IN CASE OF ANY MISTAKE, a fine of Rs.500/-will be levied for rectification of each mistake.
- 9. The late fee amount will be levied automatically, in case the fee is not remitted to the P.U. A/c and forms are not submitted as per the above schedule. A Penalty fee of Rs. 1,000/- per day shall be levied if the college fails to submit the Examination application forms within the stipulated date, i.e., on or before 12-09-2023.
- **10.** The Principal is requested to submit the fee for the received application forms only and not to pay fee for un-received application forms. ANY EXCESS FEE PAID CANNOT BE REFUNDED OR ADJUSTED FOR ANY FUTURE EXAMINATION.
- **11.** The College Principals are requested to submit the list of Faculty members working in the college and their service particulars, subjects taught during the year and along with Contact Numbers without fail.
