### **GENERAL CONDITIONS TO THE PRINCIPALS: -**

- 1. Filled in application forms (attached with a photocopy of qualifying examination/Hall-Ticket) duly signed by the student and the Principal concerned should be submitted to the examination branch before the last date. The submission of application(s) after the last date will attract penalty of **Rs. 1000/- per day.** Xerox copies of Examination application forms & photographs will not be considered.
- 2. The Principal is requested to pay the examination fee for received application forms and not to pay the fee for un-received application forms. Any excess fee for un-received application forms are not refundable.

- 3. The Principal is requested to verify and forward all the application forms immediately along with the Name List (Nominal Roll) in prescribed Proforma, (Consisting name, Father's & Mother's name, Gender, Category and the theory and practical papers registered for the exam) subject wise & fee particulars in duplicate and "NO DUES CERTIFICATE" from the Director, Academic Audit Cell, PU, shall be enclosed with the forwarding letter.
- 4. Principals are advised to collect **Three copies** of **project report** from each **VIII Semester candidates**, which should be produced at the time of Viva-Voce for the use of Examiner(s) deputed for conduct of the Viva-Voce Examination on the specified date(s) as per Almanac. The Principals are requested to forward **One** copy of the project report of each student who have registered for VIII-Semester Examination duly certified by the Supervisor and Principal of the college along with **TWO copies** of Nominal Rolls. **Those candidates who do not register for the VIII -Semester Examination will not be considered for taking the Examination**. The Principals are requested to contact the **Controller of Examination** for the dates of final Viva-Voce.
- 5. Not to collect the Exam fee (In case of VIII Semester students (collect memo's fee, consolidate memo's fee and Provisional certificate fee) and in case of I, III &V Semester students (collect memo's fee only) from the Visually Challenged, Physically Challenged, Hearing Impaired & Orally Challenged students. A Xerox Copy of Medical Certificate confirming their status as Physically Challenged (Minimum percentage of disability must be of 40%) must be attached to the Application forms. These Students' Application forms should be submitted separately along with Separate Nominal Roll.
- 6. All the principals are requested to advise the students to deposit Examination fee into their respective College Principal's Accounts only (students are advised not to obtain the DD in favour of the "Controller of Examinations", PU)
- 7. The concerned Principal's are requested to transfer the fee amount through RTGS / NEFT for credit into Registrar, Palamuru University Exam Fee Fund A/c No. <u>62078258948 (SBI, Ganesh Nagar Branch, Mahabubnagar, IFSC Code "SBIN0016375"</u>) and obtain a receipt from the bank and submit the same to the Examination Branch, PU along with application forms. No Demand Drafts are accepted at core banking section at Exam Branch.
- **8.** Last date for submission of application forms & nominal rolls along with payment fee details to the Controller of Examinations, PU is <u>09-06-2023</u>.
