- It is hereby notified to all the concerned that M.Sc., 5 Year Integrated Chemistry X-semester (Regular/Backlog/Improvement) examinations will be conducted in the month of MAY, 2024.

- 2. PAPER-WISE IMPROVEMENT IS PERMITTED FOR ALL X SEMESTER CANDIDATES AFTER COMPLETING THE RESPECTIVE SEMESTER EXAMINATION AT A TIME ONLY.
- 3. <u>Candidates belonging to the academic year 2010-11 and prior to this academic year should not apply for any of their backlog paper(s).</u>
- **4.** Further, it is informed that the candidates of M.Sc. 5 Yr Integrated Chemistry who were admitted during the Academic year 2011-12 & 2012-13 (i.e., 2011 Batch & 2012 Batch), have to PAY Rs.1000/- for each backlog paper in addition to normal examination fee.
- **5.** This is the last chance for the candidates admitted during the academic Year 2011-2012 to appear for the backlog examinations.

iii) Improvement Fee : Exam fee +Rs. 110/-(per paper)+100*

GENERAL CONDITIONS TO THE PRINCIPALS:

1. Filled in application forms (attached with a photocopy of qualifying examination / Hall-Ticket) duly signed by the student and the Principal concerned should be submitted to the examination branch before the last date. The submission of application(s) after the last date of 2 will attract penalty of Rs. 1000/- per day. Xerox copies of Examination application forms & photographs will not be considered.

- 2. PAPER-WISE IMPROVEMENT IS PERMITTED IN THE NEXT IMMEDIATE EXAMINATION AFTERCOMPLETING THE SEMESTER AT A TIME ONLY.
- 3. <u>Principal is requested not to forward / submit the EAF of ineligible candidates. The results ofineligible candidates will be cancelled, if at all they have written the examination.</u>
- 4. The Principal is requested to pay the examination fee for received application forms only and not to pay the fee for un-received application forms. Any excess fee paid is not refundable.
- **5.** Candidates appearing for X Semester shall enclose Xerox copies of previous semesters memoranda of marks.
- **6.** The Principal is requested to submit **COMPULSORILY** the following documents, otherwise their forms will not be accepted.
 - i. The detailed **Fee Statement** signed by the College Principal.
 - ii. Proforma of **Paper-Wise strength** particulars signed by the Principal.
 - iii. A separate nominal roll for the backlog candidates
 - iv. The Clearance Certificate from the Director, Directorate of Academic Audit, P.U.
- 7. Not to collect the Exam fee except fee for memorandum from the Visually Challenged, Physically Challenged, Hearing Impaired & Orally Challenged students. A Xerox Copy of Medical Certificate confirming their status as Physically Challenged (Minimum percentage of disability must be of 40%) must be attached to the Application forms. These Students' Application forms should be submitted separately along with Separate Nominal Roll.
- **8.** All the students are hereby instructed to deposit Examination fee into their respective College Principal's Accounts only and are advised to not to obtain the DD in favour of "Controller of Examinations", PU.
- 9. The concerned Principal is required to credit the fee amount into **Registrar, Palamuru University Exam Fee Fund A/c No. 62078258948 (SBI. Ganesh Nagar Branch. Mahabubnagar. IFSC Code: SBIN0016375)** through **RTGS / NEFT**, obtain a receipt from the bank and submit the same to the Examination Branch, PU along with application forms.
- **10.** It is hereby informed to all the X-Semester regular students of 2018 batch that the date for the submission of project work Comprehensive Thesis is on or before **31-05-2024** and the Viva-Voce Examination will be conducted on **04-06-2024**.
